 - Danish Agriculture & Food Council "Climate-neutral agriculture and food industry 2050". Activities to be continued.




The Danish food industry is launching a vision to be climate neutral by 2050, while sustaining or even increasing food production.

• What are your country's needs?

- It is important for Demark to expand participation in international projects and extend the use of international research under Danish conditions. We request that the rules for implementing important instruments as Operational Groups, Strategic Networks and the acknowledgement of the AKIS system as a whole in the strategic plans are suitable flexible and non-bureaucratic to account for national strengths and differences in the national AKIS systems.
- Which measures for modern and interactive advisory services are being taken already
 - Denmark has overall a well-functioning AKIS with strong links between universities, public ministries and agencies, agricultural knowledge centres, agricultural colleges and vocational schools, advisory companies, and farmers and vice versa.
 - COVID-19 has accelerated the use of digital forms of communication.

- Which measures for modern and interactive advisory services are being planned post 2020
- The Danish AKIS and advisory system are responsive towards the needs of the farmers and the demands and wishes from the political system and the public. This cooperation is expected to continue to be expanded. Examples are;
 - Closer co-operation between authorities, researchers, advisors and farmers in precision farming – new partnership "Smart Regulation".
 - Focus on communication and implementation of new knowledge.
