# Characteristics of your AKIS: SWOT

- Current situation: Focus on knowledge innovation and digitalisation
- Inventory of the agricultural knowledge system in Germany by EU-funded Pro AKIS project
- Different regional levels /federal government, state region and institutional anchors
- Agricultural research and the agricultural extension system are described as pluralistic, under strong change, especially digitization
- Other actors such as media, consumers, stakeholders, businesses at all levels
- EIP Agri - European Innovation Partnership "Agricultural Production and Sustainability": project-related implementation at country level in the framework of Operational Groups
- Association Chambers of Agriculture: 7 regional Chambers of Agriculture + associated Members of “Länder” organizations where no chambers exist – national networking platform, committees and working groups eg. committee “Farm-Management and Advice” or “Rural development and resource efficiency” as well as a working group for private and public advisors, our members run also experimental stations and training centers as well as research institutes which provide laboratory testing and advisory services (e.g. soil, water)
- Member of EUFRAS – European Forum for Agricultural and Rural Advisors



## Recommendations (EU Commission)

AKIS in Germany is strong, but fragmented,  
there is a lack of cooperation and coordination within the knowledge networks

About 3 % of rural development budget is allocated to knowledge and innovation priority

- **M1 Transfer of knowledge and information measure**
- **M2 Advisory services,**
- **M16 Cooperation EIP Agri**

## Recommendations for Changes:

Simplification, systemic, holistic approach, new topics,  
digitisation in agriculture, advisory services and managing bodies,  
education and training of advisors


