- Gather diferent actors Mission Soil CAP... Webminar april 2021,
- OG on soils supra regional, regional, and Horizon 2020 Projects.
- The AKIS coordination body proposed... Multiactor too:
- Dimensions: 1) Ministries regions + 2) Food chain + 3) profiles
- Research institutions at national level (CDTI, CSIC, AEI), networks
- of Universities (eg: Excellence Campus) + reg goverments
- (preferably with regional reseach-tech centres) + sector (n professional organizations)

- art 78. Information and knowdlege transfer. For national associations (&/or nat consortia) for coherent package of actions for information / training / demonstration about digitalization. 200.000 euros for 24 months.
