### 1. EIP synergies

Good solutions for the present situation described in the 4th mandate report:

- Effective regional, national and transnational networking
- Adapting researchers and advisor's activities to their broader roles
- Drawing in researchers in the co-creative innovation with farmers and advisors
- Evaluating positive AKIS elements without administrative burdens



### 2. Greater impact of MAA

This work will result in recommendations for the European R&I community to set-up and implement more impactful MAA projects:

- Learning from a number of Flagship H2020 projects
- Learning from innovation support services supporting enabling environments
- Supporting interactivity and capacity building within MAA
- Scaling up innovations, with attention for SMEs
- Exploring targeted follow-up RIA projects for exploitation
- The role of advisors in knowledge transfer in MAA



#### 3. Role of Education

Raise awareness of Member States to include educational programmes with interactively updated content in their AKIS strategies and action plans:

- Skills of effective learning, problem solving and interacting with society
- Farmers in agricultural lifelong education
- Direct and indirect transgenerational knowledge sharing
- Design an efficient and attractive Erasmus exchange program
- Integrating educational organisations in projects
- Convering CAP, Horizon Europe and EU educational programmes

#### 4. Digitisation in our service

Propose actions and policies to promote more inclusive and fair digitisation processes in the agri-food sector in Europe:

- Knowledge Reservoirs of use for agricultural practice
- Smart Farming techniques, building interrelations between data from various sources
- Smart Villages approach
- Existing AKISs examples to foster open data management
- What should be open and public, what should be private
- Explore how to make the digitisation process inclusive for SMEs



#### 5. Social innovation

Help Member States to include social innovation in their AKIS strategy and action plans:

- Existing national/regional AKISs which foster social innovation
- Replication and scaling-up of social business models
- Capacity to build regional and international initiatives by promoting cross-links between local agriculture and social entrepreneurs
- Promoting social innovation with significant impact on the 'real world'
- Fitting social innovation actions into the rural development and R&I policies



#### + Collaboration theme

Steping up the impact of the different SWGs in giving advice to the Member States and the EC on the coordination of agricultural research and innovation

- Continue and extend the collaboration between SCAR
  WGs and SWGs and the relevant networks/platforms
- Fostering SDG EU commitments
- Discussing specific topics
- Discussing general topics
